Village of Deer Park Regular Board of Trustees Meeting Minutes January 19, 2009

1) PLEDGE OF ALLEGIANCE AND CALL TO ORDER

The regular meeting of the Board of Trustees of the Village of Deer Park was held on Monday, January 19, 2009 at Vehe Barn, 23570 W. Cuba Road, in the Village of Deer Park, in the counties of Lake and Cook, Illinois. President Gifford called the meeting to order at 7:00pm. Village officials and guests recited the Pledge of Allegiance.

2) ROLL CALL AND DETERMINATION OF A QUORUM

Upon roll call, the following were present: President Gifford, Trustees Pratscher, Kizior, Kellermann, and Thrun. The following Village officials were absent: Trustees Plautz and Rotter. Other Village officials present were Administrator Connors, Clerk Meyle, Attorney Keller, Permit Coordinator Doniec, Treasurer Stade, and Kildeer Police Chief Lilly. President Gifford stated there is a quorum.

Also in attendance was Dale Perrin of the Lake Zurich Chamber of Commerce, Pat Winkelman of the Vehe Farm Foundation, and Jack Shapiro of 22591 Covington Drive.

ITEM 13 WAS ADDRESSED AT THIS TIME – Kildeer Police Reports – December 2008

Chief Lilly addressed the Board regarding the past month's activities which included the following:

- Sixty weather related traffic crashes
- As a result of the economy, there has been an upswing in the number of thefts from automobiles (i.e. GPS units, cell phones). Residents are encouraged to keep items of value that are in their car out of sight.
- Residents are reminded to keep the streets clear of parked cars when there is any significant snowfall.
- Kildeer Police Officer Hoover will be serving with Illinois National Guard in Afghanistan for the next two years.

ITEM 9 WAS ADDRESSED AT THIS TIME – Lake Zurich Chamber of Commerce Request for Waiver of Fees

Dale Perrin addressed the Board regarding complimentary use of the Vehe Barn for the Lake Zurich Chamber of Commerce (LZCC) 2009 bi-monthly Business Connections luncheon meetings. Mr. Perrin confirmed that the Village Event Coordinator will be exhibiting the Vehe Barn at the LZCC Business & Community Expo in March and that the LZCC is waiving all booth registration fees for that exhibit.

C) Payment to American Underground for storm sewer cleaning and televising (\$3,776.25)

D) Update on the Deer Park 2009 Road Program

The Board discussed the 2009 Street Maintenance Program Project Update submitted by Engineer Gordon on January 15, 2009.

<u>MOTION</u>: by Trustee Thrun to approve an updated 2009 Road Repair Budget of \$630,000.00 which includes a \$20,000.00 net for the Ferndale Phase III drainage improvement project for total of \$650,000.00.

The expected expenditure for the Ferndale Phase III drainage improvement project is \$55,000.00; there is an expected savings of \$35,000.00 for the road repair budget to be realized by combining the Ferndale drainage work with the road repair work; thus, the net \$20,000.00. Upon voice vote: YES: (4) / NO: (1) / ABSENT: (2). Motion carried 4/1

E) Cook County Highway Department - Quentin Road Widening

Administrator Connors reported that on January 14th he and Engineer Gordon met with officials from the Village of Palatine and the Cook County Highway Department (CCHD) to discuss the widening of Quentin Road.

Administrator Connors explained that the CCHD would like Deer Park's formal acknowledgement of the following:

- The Board's support for the widening project.
- The Board's interest in completing the sidewalk on the east side of Quentin Road, north of Hillcrest Drive.

The consensus of the Board was that they support the widening of Quentin Road from Lake Cook Road to Dundee Road by the CCHD and they want the exhibits submitted at the April hearing to include the sidewalk in Deer Park on the east side of Quentin Road, north of Hillcrest Drive and across Lake Cook Road with the understanding that they are not agreeing to pay for anything at this time.

F) Metropolitan Pump Company's Annual Maintenance Contract for the Long Grove Lift Station

MOTION: by Trustee Thrun to enter into a service contract with Metropolitan Pump Company to provide preventative maintenance for the Long Grove Road Lift Station in the amount of \$2,120.00 to be paid out of the Sanitary Sewer Fund. Attorney Keller reported that the Village successfully completed the acquisition of the Charles E. Brown Park property from Lake County and received the deed for the property.

A. <u>President Gifford</u>:

i) General Information

President Gifford updated the Board regarding the approval of the Canadian National Railway acquisition of the EJ&E Railway by the Surface Transportation Board. President Gifford stated that the Barrington Area Coalition (which Deer Park is a member) continues to look into other ways to stop the acquisition. President Gifford confirmed that the EJ&E Quiet Zone that runs through Deer Park transfers to Canadian National and will remain in place.

ii) Lake County Municipal League Dues in the amount of \$865.23

E. Trustee Pratscher – Planning and Zoning:

Trustee Pratscher reported that she received a report from Permit Coordinator Doniec showing that permitting for residential and commercial building projects was lower than projected for 2008.

F. <u>Trustee Rotter – Parks and Recreation:</u>

Hummingbird Court Landscape Reimbursement

A discussion ensued with the Board deciding to postpone approval of this reimbursement to give Trustee Rotter the opportunity to rework the figures pertaining to the removal of the dead tree (which was not preapproved) and the weed control expense (which is not reimbursable per the reimbursement guidelines).

Administrator Connors reported that Trustee Rotter asked him to get feedback from the Board regarding whether they want to negotiate with the existing landscaper or seek formal bids for next year's park landscape and maintenance services. Trustees Kizior, Thrun, and Pratscher favored negotiating with the existing landscaper while leaving the option to seek formal bids open if the negotiations aren't favorable. Trustee Kellermann favored only seeking formal bids.

G. <u>**Trustee Thrun – Public Safety:**</u> – addressed earlier in the agenda Request for a Stop Sign at Covington and Landmark (Swansway Subdivision)

H. Administrator Connors:

Administrator Connors reported that he continues to meet with RedSpeed to coordinate and facilitate the implementation of red light photo enforcement at Quentin and Lake Cook Roads, Rand Road and Deer Park Boulevard, and Rand and Long Grove Roads; he is hopeful to see more progress in the spring as the winter weather has slowed the traffic study process.

Administrator Connors reported that he and Event Coordinator Keith are putting together a recommendation for the restructuring of the Vehe Barn rental fee structure which will be presented at the February meeting; the goal of the restructure is to attract smaller, non-resident events.
