MINUTES OF A PUBLIC MEETING OF THE BOARD OF TRUSTEES OF THE VILLAGE OF NORTH BARRINGTON, HELD ON NOVEMBER 27, 1972, AT THE NORTH BARRINGTON SCHOOL IN SAID VILLAGE

Clerk Tingleff called the roll. Acting President Schulke paused for a brief meditation.

Trustee Carlson moved that the minutes of the meeting of October 23, 1972, be approved as prepared; seconded by Trustee Forrest and passed unanimously.

VILLAGE OFFICERS

TREASURER - Treasurer Ypelaar presented a Treasurer's Report for the period ending October 31, 1972, showing balances as follows:

Trustee Carlson moved adoption of the Treasurer's Report; seconded by Trustee Forrest.

Nays: None

Absent: Trustees Ofsthun and Talbot

The Acting President declared the motion carried.

Treasurer Ypelaar then presented the "Flash Report" of receipts and expenditures for the period November 1 through 22, 1972, material from Mr. Thomas B. Blanco, Purchasing Agent for the State of Illinois, regarding the joint purchasing program, which Acting President Schulke directed to be placed in the Village Clerk's file for use by Village Officers, and a memorandum from McGladrey, Hansen, Dunn and Company explaining the Revenue Sharing Act. After discussion of the latter matter, Acting President Schulke appointed Treasurer Ypelaar to be the coordinator of the Revenue Sharing Act for the Village of North Barrington.

<u>CLERK</u> - Clerk Tingleff presented four vouchers for payment from the general corporate fund totaling \$5,011.81. After discussion, Trustee Forrest moved to approve payment; seconded by Trustee Carlson.

Absent: Trustees Ofsthun and Talbot

The Acting President declared the motion carried.

Clerk Tingleff then presented Audit Report No. 9 which was received from the State of Illinois covering the receipt and disbursement of Motor Fuel Tax Funds by the Village of North Barrington for the period January 1, 1971, through December 31, 1971. Trustee Forrest moved that the Board of Trustees receive and file this report; seconded by Trustee Carlson and passed unanimously.

BOARD OF APPEALS - Chairman Hammer reported that there was currently a petition from Edward C. Prest before the Board of Appeals which would be the subject of a Public Hearing on Wednesday, November 29, 1972. He then briefly reviewed the petition. Chairman Hammer also announced the forthcoming resignation of one of the members of the Board of Appeals and Acting President Schulke stated that he would attempt to have a candidate to fill this vacancy as well as another that existed at the December meeting.

HEALTH - Health Officer Cameron reported that she had received quotations of from \$300 to \$350 for an aerial survey of the Village and that aerial maps of North Barrington under flood conditions were not available from existing sources.

Health Officer Cameron further reported that it is the feeling of the Health and Sanitation Commission that the cause of the septic failure at 205 Biltmore Drive is a drainage problem of surface water which is under the jurisdiction of the Road Department. A discussion followed on similar conditions at other locations in the Village, and Acting President Schulke stated that there is need for a program to eliminate flooding caused by blocked culverts on Village property, perhaps as a part of the MFT program.

Acting President Schulke reported that the Village of North Barrington's Flood Plain Ordinance would perhaps qualify residents for Federal Flood Insurance and referred this matter to the Committee on Planning and Zoning for study. He further reported that he had requested a report from the EPA on the status of the enforcement action regarding the Lake Zurich sewage plant.

Acting President Schulke then called attention to the memorandum from Village Attorney Braithwaite stating that open burning is still prohibited in the Village of North Barrington as a result of Illinois Pollution Control Board Rules and Regulations. After discussion on the matter, it was agreed that the Village of North Barrington ask BACOG to research the matter further and perhaps petition for relief.

BUILDING AND ZONING - Officer Ray reported that he had studied further the 1971 SBOC Code and still felt that with slight improvements, the Village of North Barrington should consider adopting it in place of the present code.

Acting President Schulke asked Officer Ray to present his recommendation in writing to the Committee on Building, Health and Sanitation for their study and preparation of an ordinance amendment for consideration of the Board of Trustees.

OTHER OFFICERS - Acting President Schulke stated that he had received a copy of a letter that Mosquito Abatement Superintendent Ritchie had sent to Midas Midwest Inc. acknowledging receipt of a proposal for the 1973 program and indicating that quotations are requested in April. He further stated that Timothy L. Wright, the Executive Director of the Lake County Soil and Water Conservation District had now requested to receive minutes of all Zoning Board of Appeals and Plan Commission meetings and hearings. Finally, Acting President Schulke requested a brief summary of the activities of all departments during the last 12 months, for use in composing a forthcoming newsletter to all residents.

COMMITTEES OF THE BOARD

Planning and Zoning - Trustee Forrest reported that the committee would be meeting in the near future and would be making a final recommendation on the proposed amendments to the Zoning Ordinance regarding trailers, pickup coaches, motorized homes and boats and the raising and keeping of certain animals; that he felt the Village of North Barrington had had excellent representation at a recent hearing in Waukegan regarding the proposed comprehensive sewage treatment facility in southwest Lake County; that there were now six new members on the Lake County Plan Commission; that he had read there was a new land use proposed for the northwest corner of Routes 12 and 22; that an application is being filed requesting the rezoning of the Barton property on Arrowhead Lane which would increase the density by 21/2 times; and that the membership of the Lake County Zoning Board of Appeals had been declared unconstitutional. After discussion of these matters, Acting President Schulke referred the matter of the land use at Routes 12 and 22 to the Committee on Planning and Zoning for study, and the matter of the rezoning application for the property on Arrowhead Lane to the Plan Commission for review and recommendation.

OLD BUSINESS

Acting President Schulke presented proposed Ordinance No. 88.3, an ordinance amending the Zoning Ordinance of the Village of North Barrington. After discussion, Trustee Forrest moved adoption of Ordinance No. 88.3; seconded by Trustee Carlson.

Absent: Trustees Ofsthun and Talbot

The Acting President declared the motion carried.

Acting President Schulke noted that proposed Resolution No. 376 officially granting a variation from the Health and Sanitation Ordinance which was passed by a motion at the October 23, 1972, meeting, was in draft form awaiting approval from Village Attorney Braithwaite.

Acting President Schulke reported briefly on the status of the shared village management services program which has been introduced by BACOG, stating that he had presented North Barrington's views, but that since the Village of Barrington had the facilities for such a program and since the grant was designed to be given to a municipality, he had voted to support Barrington's application for the grant. He then asked that the Committee on Finance and Law determine in what areas the Village of North Barrington could best participate in such a program and present its recommendations at the December meeting.

Acting President Schulke reported that with regard to the Flynn Creek Annexation, the Appellate Court of Illinois for the Second District denied our petition for Rehearing on November 9, 1972. After discussion, Trustee Forrest moved to authorize the Village Attorney to present a petition for leave to appeal to the Supreme Court of Illinois and follow through if granted; seconded by Trustee Carlson.

The Acting President declared the motion carried.

NEW BUSINESS

Acting President Schulke called attention to a memorandum from Village Attorney Braithwaite dated November 20, 1972, with regard to a suit against the Lake County Collector by the Diamond Lake School District. No action was taken, as was the recommendation of the Attorney.

Acting President Schulke presented proposed Ordinance No. 67.2, an amendment to the Dog Ordinance, and then referred it to the Committee on Finance and Law for their review and recommendation.

HEARING OF CITIZENS

Robert Smith, 205 Biltmore Drive, thanked the Health and Sanitation Commission for their help in correcting temporarily the surface water situation on his property, and asked that the Village consider a permanent solution since the road was involved in the problem. Donald Smith, 206 Biltmore Drive, asked that the Village consider the effect on Honey Lake in whatever means they use in solving water drainage problems in the Village. In the discussion that followed, and upon questioning by Building and Zoning Officer Ray, both Robert Smith and Donald Smith stated that the addition recently put on at 199 Biltmore Drive was not causing the drainage problems.

At 10:25 P. M. Trustee Cragg moved that the meeting be adjourned to a date certain, December 18, 1972; seconded by Trustee Carlson and passed unanimously. The Board then went into executive session.
