President Caldwell announced that this meeting marked the completion of the fiscal year. The Clerk called the roll, and the President led in a brief meditation. Trustee Saville moved that minutes of the meeting of February 23, 1970 be accepted as prepared; seconded by Trustee Huning and passed unanimously.

Report of Planing and Zoning Committee on Meadow Wood Hills Plat - Trustee Forrest stated that his committee had decided not to make a recommendation tonight because they feel an obligation to the Village and to the total Barrington area to give full consideration to all conditions involved. They had been unable to meet with Mrs. C. K. Hunter, who owns approximately 80 acres adjacent to and into which this subdivision would drain, until last evening as she had been out of town. They also wished to determine and comply with directions provided by the recently published BADC reports, and would like to have Building and Zoning Officer Ray meet with Mrs. Hunter prior to another meeting of the committee with her and her attorney.

Trustee Huning moved that the Planning and Zoning Committee continue to study the proposed Meadow Wood Hills Subdivision and make a recommendation to the Board within sixty days, or if possible within thirty days; seconded by Trustee Saville.

Albert Hall, Waukegan attorney representing the developers, was recognized and said he was not familiar with all requirements of North Barrington to obtain approval for a subdivision such as this, but that this is a critical time of

the year for builders. He also said that since the surrounding villages had already approved the proposed subdivision, it would appear that additional delay would be an imposition on the developers at this time and he wondered if the committee could not rely on the judgment of neighbors in this matter.

President Caldwell asked if he intended to imply that North Barrington should approve just because other neighboring villages had done so, and Attorney Hall said this was not the case.

Benjamin Borkon, the developer, was recognized and said that they were very much concerned with complying with good ecology and good land use, and maintaining the character of the area. He said he planned to build a home for himself on Lot No. 7, and that he had spent many hours during the past year planning the development. He hoped the Board would recognize him as a cooperative developer who is not interested in being at odds with his neighbors.

Trustee Forrest stated that his committee would make every effort to complete the study in thirty days and expected to be able to do so.

The motion was then put to a vote.

Several items were discussed. Trustee Huning asked if plans had been made for use of MFT Funds. President Caldwell answered that such plans are being formulated but are not yet complete. Trustee Huning moved adoption of the Treasurer's report as presented; seconded by Trustee Saville.

The President declared the motion carried.

President Caldwell announced that because of the pressures of other duties, Treasurer Gerry has asked to be relieved of the responsibilities of Treasurer as of July 1, 1970. President Caldwell praised the very efficient manner in which Treasurer Gerry had kept the Village accounts, and then introduced Bernard J. Ypelaar as prospective Treasurer beginning July 1.

<u>Village Clerk</u> - Clerk Davis presented a general voucher totaling \$2,652.19 for approval of payment from the corporate funds. Trustee Huning moved to approve payment; seconded by Trustee Forrest.

Clerk Davis presented a voucher for the Police Department totaling \$677.78 for approval of payment from the corporate funds. Trustee Forrest moved to approve payment; seconded by Trustee Davis.

The President declared the motion carried.

President Caldwell presented an invoice for \$2975.00 for legal services other than the regular retainer during the past 23 months and \$300 retainer for January, February and March, 1970 from King, Robin, Gale and Pillinger.

The Trustees questioned the late billing and asked the amount of carry-over from last year. President Caldwell said that the amount of carry-over could not be ascertained accurately as the fees were billed by cases, but that a request has been made for legal fees to be billed on a quarterly basis in the future. Trustee Forrest called attention to the fact that a large portion of the legal fees represent zoning protection costs, verifying the determination of the Board to keep the land use pattern as it is or to better it. He then moved that the budget be amended to increase the amount for Legal Services (other than retainer) to \$4,675 and total Legal and Auditing to \$6200, these being the total amounts appropriated for the purpose, and that payment of \$3000 to King, Robin, Gale and Pillinger be authorized -- \$300 as the balance of the annual retainer and \$2700 on account toward their March 21 statement of legal services other than retainer. Seconded by Trustee Saville.

<u>Police</u> - Chief Roy Svacha distributed copies of Police Department Activities. After discussion, President Caldwell introduced Thomas James Truax, as a prospective appointee to the Police Department. Trustee Huning took the opportunity to praise the work of the Police Department and then moved adoption of Resolution No. 309, appointing Thomas J. Truax a Probationary Police Officer; Trustee Davis seconded.

The President declared the motion carried.

Building and Zoning - B&Z Officer Ray presented a Building and Zoning Office report of activities in the village, discussed current work being performed, and told of some problems with certain areas. Trustee Huning commended Mr. Ray for the report and all trustees agreed it is very informative and helpful.

<u>Plan Commission</u> - Chairman Clarke reported the following results of a Plan Commission meeting on March 10:

Definition of golf course proposed for including in the Zoning Ordinance:

"A tract of land for playing golf, including fairways, greens, tees, and rough, of not less than 100 acres. A clubhouse and other accessory buildings incidental to the operation of a golf course or the playing of tennis may be located thereon, provided their location, construction and use comply with all other ordinances. No use other than the foregoing shall be construed as coming within the definition of a golf course. This prohibition shall include, but not be limited to the provision of facilities which would allow any other outdoor game or related activity other than golf or tennis to take place at any time. No lighting may be installed which would allow any outdoor game or related activity to take place except between the hours of sunrise and one hour after sunset."

Subdivision Regulation Enforcing Officer Weaver was assigned to check the progress of East Oaksbury and Alcon subdivisions, but had not made any report.

Commission member Moody was assigned to check progress on the flood plain zoning ordinance and report on it in the near future.

It was voted to recommend annexation of two island properties (Lot No. 6 in Cherry Hills subdivision and the former Campau property on Miller Road).

Building Officer (House Numbering) Fenner, who has been keeping the Village Map up to date, and Chairman Clarke have obtained an estimate of approximately \$400 to have an original Milar copy of the map made. Other estimates will be sought. An atlas-type of map was considered but thought to be too unwieldy, would include much unnecessary detail, and would consist of so many pages that it might cost as much in the long run.

President Caldwell commended Officer Fenner for the excellent work he has done in keeping the Village map up to date and said that a new map is long overdue.

Chairman Clarke announced future Plan Commission meeting dates of May 5, July 7, September 8, and November 10 at 162 North Signal Hill, unless otherwise advised and/or a public hearing is scheduled.

Trustee Forrest asked Chairman Clarke to consider with his committee how the Barton-Aschman reports might guide or help the Village in long-range planning.

No other village officers wishing to be heard, the meeting proceeded to reports of committees of the Board.

Health and Sanitation - Trustee Saville presented a plan for draining the area along Golfview and Eton Drive. The increasing amount of water standing in this area constitutes a hazard, is a mosquito breeding area, and is damaging the road bed. Trustee Saville was asked to check with the Village Attorney concerning any implied obligation if other property owners might want other areas drained, or if the area should be drained and then an owner should decide to build on it. It was suggested that perhaps no action should be taken until the flood plain zoning is completed and that the Committee on Roads and Public Utilities should be consulted.

Trustee Saville then presented a rough draft of a pond ordinance and recommended that it be retyped and considered at the next meeting. Trustee Davis stated that lakes and ponds are a definite asset to the community -- they are very useful in case of fire, maintain the ecology, and prevent over-building in the area -- and should be encouraged. President Caldwell commended Trustee Saville for good work on the ordinance and directed that a proposed ordinance be prepared prior to the next meeting.

Roads and Public Utilities - Trustee Davis said that county roads in the village are posted for weight limits of four tons per axle during spring thaws or when weather conditions are such that roads might be damaged. After discussion, he moved adoption of Ordinance No. 1444 amending regulation as to weight of vehicles on village roads and streets during such periods to four tons per axle. Seconded by Trustee Forrest.

Planning and Zoning - Trustee Forrest reported as follows:

Since the zoning ordinance specifically excludes trailers in zones R-1, R-2, and R-3, he has looked at several trailers in the village, some of which neighbors find objectionable. Building and Zoning Officer Ray was asked to communicate with trailer owners and otherwise investigate the entire matter.

Ordinance No. 110, allowing a zoning variation for the Evans property at the southwest corner of Miller Road and Woodland Drive was presented. After discussion, Trustee Forrest moved adoption of Ordinance No. 110; seconded by Trustee Huning, who commended all parties involved in reducing the number of non-conforming lots in the northern portion of that block from three to one.

The President declared the motion carried.

A map was displayed illustrating various corridors being studied for a freeway from Elgin northward. After considerable discussion, Trustee Carlson moved that the Village go on record as favoring Corridors Nos. 15, 16 or 17 over any other corridors that have been suggested for the proposed Fox Valley Freeway, and that Trustee Forrest be directed to make this known to those concerned with studying this matter. Seconded by Trustee Saville and passed unanimously.

He described actions to date in the Winston Lakes Development and reminded all the trustees that the next meeting is scheduled for 1:30 p.m. on April 29 in the Barrington Public Safety Building.

Committee on Finance and Law - Trustee Huning stated that he is still attempting to obtain a suitable insurance package for the Village but has little hope left of getting it. He may recommend adding some separate insurance instead.

President Caldwell described activities concerning the formation of a Barrington Area Council of Governments and presented for consideration Resolution No. 310; accepting membership in such Council, in connection with which he read a letter of opinion from Attorney Braithwaite. After discussion Trustee Huning moved adoption of Resolution No. 310; seconded by Trustee Davis. All agreed that such an organization would be a definite asset to the whole Barrington area.

The President declared the motion carried.

President Caldwell stated that:

- Annexation proceedings continue on the Flynn Creek annexation; the next meeting is scheduled for April 23.
- 2. There has been no action since the last report on the McGowan and Schmid cases.
- 3. A summons was received on March 21 on behalf of C. Ives Waldo and the Northern Trust Company vs. the Village with respect to three parcels of property on which they were denied zoning variations. The trustees agreed to proceed with defense of the suit.

President Caldwell, as Acting Chairman of the Finance Committee, then proposed a 1970-71 budget calling for expenditures (other than MFT) totalling \$59,350 from revenues estimated at \$59,720. The budget, copies of which were presented to trustees, is a working document between the trustees and the village officers and changes can be made at any regular meeting. After discussion Trustee Forrest moved adoption of the proposed 1970-71 budget; seconded by Trustee Huning.

Old Business - President Caldwell reported that the Lake County Municipal League had met as planned; there was a good attendance, an interesting program, and the refreshments which had been provided by Barrington Vending Company as a courtesy of Trustee Saville were very much appreciated.

President Caldwell reminded the Board of the desirability of up-dating the issuance of certificates of appreciation for past trustees and other village officers. He appointed Trustee Carlson as an ad hoc committee of one to determine which trustee or past officers have not been presented with a plaque of appreciation and to recommend suitable wording for such presentation.

President Caldwell stated that he would not be able to attend board meetings scheduled on May 25 and June 22 and asked trustees to consider before the next meeting whether or not to change wither of the dates.

At 11:07 p.m. Trustee Carlson moved that the meeting be adjourned; seconded by Trustee Davis and carried unanimously.
