

Minutes of the Board of Directors Meeting,
May 10th, 1966, Barrington Women's Club.

The May 10th Board of Directors Meeting of the Barrington Women's Club met at the home of Mrs. Harvey Robbins, and was called to order at 9:30 A.M. by the President, Mrs. Hile. The following members were absent: Mesdames Pegelow, represented by Mrs. Bræon, Lindgren, Work, Albrecht, Davies, represented by Mrs. Williams, Sanders, Obenhouse, Chiorgno, Paulson, Johnson. Minutes of the April 13th meeting were read and approved.

Mrs. Beckwith, Treasurer, presented the following report:

Mrs. Beckwith made a motion requesting the Board to authorize her to transfer \$250.00 to the Scholarship Fund instead of the 5% per members' dues presently called for. Said motion was second and carried.

Mrs. Kaercher reported she had contacted the printer of the Year Books and that arrangements have been made for printing the books for the year 1966-67, and urged all department heads and committee chairmen to notify her by the end of this month of all dates and programs for next year's meetings, and to notify her, in writing, by the end of June of such dates and programs. Mrs. Wright suggested to Mrs. Kaercher that the Philanthropy Report appear in the Year Book directly after the Budget Report. Mrs. Krause suggested that all monies given for Philanthropy during the year be listed under Philanthropies.

Director Mrs. Zoern reported receiving a letter from the Auditorium Theater Council regarding the need for donations to be used for refurnishing the remodelled Auditorium Theater. Mrs. Rockwood made a motion to donate \$100.00 to the Auditorium Theater Council. Said motion was seconded and carried.

Mrs. Hile asked all chairmen to send her their reports, and urged all Department and Committee chairmen to be present at the May 18th General Meeting when the new officers will be installed. Mrs. Hile also announced there will be a Bowling Group next year, and after discussion of the desirability of creating a Recreational Activities Department, it was decided to refer this to the new Board Meeting in June. Mrs. Hile also mentioned there would be announcements at the General Meeting by the chairmen of Civics, Membership, Ways & Means, and Membership dues.

Mrs. Williams, for Mrs. Davies, reminded the Board of the Field Trip to be held on May 17th. Mrs. Robbins, Conservation chairman, announced the last Bird Walk of the season to be held on May 12th. Mrs. Rockwood, Home Arts chairman, asked permission to purchase a Teapot for the Women's Club to be used with the Coffee Service, said purchase to be paid for with money left over from the Home Arts Budget. Said motion was made, seconded and carried. Mrs. Fullerton, Literature chairman, commented on the fine Book Review presented by Ruth Paulson at the April meeting of the Literature Group. Mrs. Hallett, requested donation of small flowers by members of the Board for use at the General Meeting. Mrs. Leeson Bridge Chairman, announced that Janet Davis will head the Bridge Group next year, and is applying for a Franchise to give fractional Master Points to players in the Duplicate Bridge Group.

Mrs. Claffey, Building Fund chairman, reported on the findings of her Committee regarding the possibility of a Building program, and requested funds to facilitate future work of the Building Fund Committee. After discussion this request was tabled. Mrs. Stephens, Jr., made a motion that Mrs. Claffey invite all Community

Work is continuing by her Committee on securing Stop lights at Hart Road and Northwest Highway. Mrs. Stephens also told of the IRENE HANS RECOGNITION DINNER to be held on May 25h, at 7:00 P.M. in the Barrington High School Cafeteria, and passed out letters to the Board regarding this remarkable person. Mrs. Beckwith made a motion to contribute \$50.00 to the Irene Hans Fund, which was seconded and carried.

MINUTES OF THE APRIL 20th GENERAL MEETING OF
THE BARRINGTON WOMAN'S CLUB

The April 20th General Meeting of the Barrington Woman's Club was called to order by the president, June Hile, at 1:05 PM


