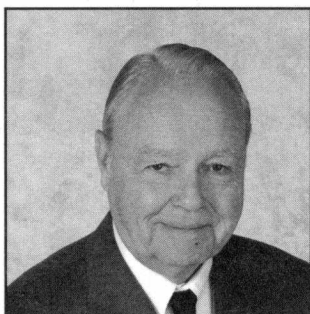

PRESIDENT'S COLUMN



The incredible response by the charities to the tragedies in New Orleans and Texas has even prompted Congress to pass favorable new legislation that supports charitable giving. Initially, the resistance was the revenue loss from the tax-deductibility of donations. That wilted because the charities were so fast and so effective in hurricane relief.

When Alexis de Tocqueville studied America in the 1840s, he observed what distinguished the New World was the sheer volume of volunteerism. Still true. No country in the world has the level of voluntary giving as we do.

And the fastest growing philanthropic segment in America is community foundations. We are a people who help people—especially neighbors.

OUR ETHICS STATEMENT

When we started in 1998, we thought we had done everything right. Board structure and procedures, mission, by-laws, investment policy. In the meantime, some charities abused the public trust. So now, we have a conflict of interest policy that every board member must sign every year. The newest requirement, even for charities, is a statement of ethics.

A task force of the board reviewed other ethics statements—some almost two pages long. We wanted a statement that was short, concise and contemporary. Here is the recommended draft, as amended in our September 19th meeting, subject to approval by our counsel:

The Barrington Area Community Foundation will carry out its mission to address unmet needs of the community so that the work of the Board of Directors will benefit the community, will be fairly and openly determined, will be accurately and properly reported, will assure the scrupulous management of funds, will provide diligent examination of all grant requests and will be based on the collective best judgment of the Board of Directors without bias or prejudice.

THE CASE FOR DONOR-ADVISED FUNDS

Donor-advised funds are a means of accomplishing your financial and philanthropic goals without setting up a trust but with tax advantages. We will work with you to create a fund in which you indicate the focus (senior citizens, health care, youth services, minority assistance, etc.) and we do the review, investigation, award in your name and audit the outcome. SPOTLIGHT ON TWO GRANT RECIPIENTS

Church Women United

About fifty years ago, women in Barrington churches began determining and filling the needs of underserved people in our community – starting a food pantry, a Christmas giving day, and providing for needs of migrant workers. In 2001 we started to cover the costs of school kits for disadvantaged students. For elementary and middle schools, these kits range from \$30 to \$50. Our project started by supplying kits in some of our elementary schools for the children who qualify for low-income benefits according to federal guidelines. Last fall, with the help of Barrington Junior Women's Club, we were able to offer supplies to all qualified elementary students in District 220.



With the wonderful grant of \$6,000 from the Barrington Area Community Foundation, we began supplying kits to students in our two middle schools, where the kits cost \$50. The kits are given out anonymously at orientation in the fall, with no one knowing how the kits were financed. The schools notify the recipient students in advance, however, that Church Women United will pay for their kits.

We are most grateful for the partnership of the Barrington Area Community Foundation.

The Barrington Area Council on Aging serves the Barrington area by providing resources, education and support to seniors and family caregivers and coordinating activities for active seniors.

In 2005-2006 BACOA will introduce "Brain Aerobics," a program focused on improving and maintaining cognitive function in seniors. Brain Aerobics classes cover six areas:



- How you learn: Discovering the strengths within your brain.
- Humor as a brain builder
- Using the eye to stimulate the mind: Visual puzzles, optical illusions and more
- Tapping both left and right brains with facts and fantasy
- Listening as a brain enhancer: Expressing opinions, reminiscing in a new context
- Words for the wise: Word games to make you think and laugh

MatherLifeways, which developed the program, conducted a two-part workshop in September, with a BACOA staff member observing the class. A second workshop will be held in February/March 2006. Thanks to the Community Foundation's support, we will be able to hire and train a program coordinator and promote the program.
