The year 2006 was a most satisfying year. While it was record-breaking, the Barrington Area Community Foundation would rather look upon it as continuing to satisfy the call of our mission to address unmet needs, in this instance satisfying more than we have ever been able to satisfy. To wit:

- Our net contributions rose to \$308,000
- Our total endowment rose 24% to \$2,235,000
- Our grants to meet community needs rose 43% to \$65,000
- We had an anonymous emergency need gift of \$25,000 that we distributed to 16 individuals or families in December, and
- We held expenses to 0.7% of net assets

The figures above are unaudited but we expect them to be very close to the final results.

The rest of this newsletter will provide more detail on the activities of the past year and the plans for 2007. What should ring through every part of this newsletter is the thanks of the Board for your support and the thanks as well from the many organizations and families that have had a need met this year that would otherwise quite likely have gone unmet—because of you.


Mike Kocmond

The figures included here represent the unaudited 2006 year-end figures.





FOUNDATION ANNOUNCES PLANS FOR \$81,000 IN GRANTS FOR 2007

Based on the increasing level of the BACF endowment, the board has announced its intent to make grants of \$81,000 to Barrington area charities in 2007. The grant application deadline is April 13th. \$25,000 IN EMERGENCY FUNDS DISTRIBUTED AT YEAR END

With funding of \$25,000 from an anonymous donor, the BACF grant committee took on the challenge of evaluating the most effective way to make Emergency Grants at the end 2006. Bob Jensen, grant committee chair, lead the effort. With the help of Cuba Township officials and leaders at Church Women United, the grant committee collected more than 50 inquiries and vetted more than two dozen. In the end the \$25,000 was distributed to 16 families and individuals, who had the most verifiable immediate needs based on those who submitted requests. "It was a very meaningful and rewarding exercise" said Jensen. He added, "we also hope that we have met the intent of the donor."



2007 GOLF OUTING & DINNER SET FOR JUNE 4TH

On Monday, June 4, 2007, BACF will hold its 5th annual golf outing at Wynstone Golf Club. This is BACF's major fund-raiser of the year. Proceeds from the golf outing will be used to support BACF's mission of addressing unmet needs in the community.



INVESTMENT COMMITTEE PURSUES ASSET ALLOCATION


In an effort to preserve the principal value of your foundation's assets, the investment committee (chaired by Gil Reich) has pursued its Statement of Investment Policy. The strategic asset allocation includes diversification into cash, bonds, and stocks. Within the stock category there is further diversification by capitalization, by style (growth and value), and international. The asset allocation is implemented through the use of "I" Shares to keep management fees to a minimum. The accompanying pie chart provides a graphic overview of the asset allocation as of December 31, 2006.

FOUNDATION WELCOMES NEW DIRECTORS: SKIP GIANAPULOS & LUIS PADILLA




