## BARRINGTON MANAGER BILL TO BE VETOED

Barrington Village President John Blanke will veto an ordinance establishing the post of village manager passed unanimously by the five village trustees present at the last board meeting, The Tribune has learned.

The unsigned ordinance will be returned to the board at the next regular meeting, May 25, with an attached veto message, Blanke said. It would take a three-quarter vote by board members to override the president's veto; since all six board members have expressed approval of the measure, Blanke predicts they'll pass the ordinance over his veto.

President May Quit

Withholding his signature is Blanke's way of expressing disapproval of adoption of the ordinance, he said. The Barrington village president earlier told trustees he'd resign if the measure were approved, saying "When the manager takes office, I go out."

Following the board action, Blanke again vowed to "step out" when the village manager takes office. He says he believe's Barrington's needs do not justify the expense of the office which he predicts will run between \$22,000 and \$25,000 per year.

Village board members, however, believe Barrington needs an executive to hold responsible for the day-to-day operations of the village. The manager, they said, would aid in routine work, freeing the president for long-range planning.





BE IT ORDAINED by the President and Board of Trustees of the Village of Barrington, Cook and Lake Counties, Illinois, that:

The Municipal Code of Barrington of 1957 be and the same is hereby amended by adding thereto and inserting therein following Article VIII of Chapter 4 thereof, the following:

"Article IX. Village Manager

4.901 Position created.) There is hereby created the position of village manager, an administrative position in the village government.

The village manager shall be appointed by the president and board of trustees, voting jointly.

4.902 Qualifications.) The village manager shall be a person qualified to perform the duties of the position.

The fidelity bond of the manager shall be in the amount of fifty thousand dollars.

4.903 Term - removal.) The village manager shall have no specified term of position, but shall remain as manager so long as he performs his duties to the satisfaction of the president and board of trustees.

The president and board of trustees, voting jointly, may remove the village manager at any time.

4.904 Acting manager.) In the event of the temporary absence or disability of the village manager, or in the event the position becomes vacant for any reason, the president and board of trustees, voting jointly, may appoint an acting manager who shall serve until the manager returns to his duties or

until a regular appointment is made.

4.905 Powers and duties in general.) The village manager shall perform all his duties and exercise all powers granted to him subject to the control of the president and board of trustees.

he shall have supervision over all appointed officers of the village, and all village employees other than library employees, and all such persons shall perform their duties subject to his direction.

The manager shall recommend to the president and board of trustees any measures desirable for the improvement of the village government or for the enhancement of the general welfare of the residents of Barrington.

He shall attend all meetings of the president and board of trustees and give the corporate authorities all information possible on matters before them.

It shall be the duty of the manager to see to the enforcement of all village ordinances, to investigate all complaints relative to the government of the village, and to perform all other duties assigned to him by the board of trustees.

He shall have custody of and control over all real estate, equipment and other property of the village not assigned by law or ordinance to any officer or other employee; and he shall keep or supervise the preparation and care of all records not so assigned to any other officer.

4.906 Hiring employees.) The manager shall have the power to hire, and discharge, all employees of the village. Provided that this authority shall not extend

to members of the police or fire departments.

4.907 Contracts.) It shall be the duty of the manager to see to it that the provisions of all contracts to which the village is a party are complied with, and to report to the president and board of trustees any violation of the terms thereof.

4.908 Purchases.) The manager shall be purchasing agent for the village and shall make all purchases authorized by the president and board of trustees unless otherwise provided by the board.

Provided that no purchase of any article or commodity to cost more than five hundred dollars shall be made, except in case of emergency, or with specific approval of the board of trustees, unless bids have been asked from two or more sellers of such article or commodity, or by advertising in a newspaper in the village.

able to all prospective bidders, and at least ten days shall elapse between the time of requesting or advertising for bids and the time specified for submitting bids to the village.

4.909 Budget.) On or before May fifteenth of each year the manager shall submit to the corporate authorities a budget, including information as to all anticipated revenues of the village and a detailed list of the anticipated expenditures for the current fiscal year.

The information contained therein shall be available for the preparation of the annual appropriation and tax levy ordinances required by law.

4.910 Reports to the corporate authorities.) The manager shall report to the president and board of trustees each month, or more often if required by them, the financial condition of the village, bills, payroll and other obligations then due and payable.

4.911 Hours of duty.) The manager shall devote his full time to the performance of his duties and shall not engage in any other employment without the consent of the board of trustees.

4.912 Cooperation with other officials.) The manager shall cooperate with and assist the village treasurer and village clerk in the performance of the duties imposed on them or delegated to them by law.

We are enclosing an ordinance which would create the position of Village Manager. We have made the post a position rather than designating it as an office, to avoid any question of being limited to a person who has been a resident for one year prior to appointment.



The ordinance gives him the power to hire all employees; but the treasurer, health officer, building inspector, electrical inspector, and superintendent of the sewer plant would still be appointed by the president. The engineer and attorney, too, would be retained as at present by the president and board.



The manager would have supervision over all appointed officers and employees, except library employees, including the police department and the fire department. But he would have no authority over the various appointed boards and commissions, such as the board of appeals, pension boards, etc.

The general provisions of the code relating to all officers and employees would apply to the manager, so there is no need to repeat them in this ordinance.

The Municipal Code of Barrington of 1957 be and the same is hereby amended by adding thereto and inserting therein following Article VIII of Chapter 4 thereof, the following:

"Article IX. Village Manager

4.901 Position created.) There is hereby created the position of village manager, an administrative position in the village government.

The village manager shall be appointed by the president and board of trustees, voting jointly.

We are enclosing an ordinance which would create the position of Village Manager. We have made the post a position rather than designating it as an office, to avoid any question of being limited to a person who has been a resident for one year prior to appointment. Saluton - a hum what dutien seperisit.

The ordinance gives him the power to hire all employees; but the treasurer, health officer, building inspector, electrical impector, and superintendent of the sever plant would still be appointed by the president. The engineer and attorney, too, would be retained as at present by the president and board.

The manager would have supervision over all appointed officers and employees, except library employees, including the police department and the fire department. But he would have no authority over the various appointed boards and commissions, such as the board of appeals, pension boards, etc.

The general provisions of the code relating to all officers and employees would apply to the manager, so there is no need to repeat them in this ordinance.



The manager plan may be adopted by two different means.

First, an ordinance may be passed creating the office of manager and assigning the manager's duties. This is a flexible program, which may be adopted at any time and may be abandoned at any time without a referendum. We will submit to the Board of Trustees a copy of the Deerfield manager ordinance, which is in good form legally and which is an example of this type of program.

The second method involves having a referendum on the question of adopting the manager plan. If the referendum carries, the manager plan must be in effect for four years before a referendum can be held to abandon the program; this program cannot be abandoned without a referendum. The procedure starts with the preparation and direculation of a petition, which must comply strictly with the statute, requesting an election on a manager plan.

We will be happy to discuss this further with the Board or a committee of the Board, after the Board has had an opportunity to study this letter and the Deerfield ordinance.

Confirming our telephone conversation yesterday:

The ordinance which you and all the trustees received with regard to the Village Manager is based on the Deerfield manager ordinance. It is not legally possible to give the manager authority to appoint the clerk, the treasurer, or the chief of police or the chief of the fire department.

You ask that the following changes be made:

- 1. That we eliminate the requirement that the manager reside in the Village after his appointment.
- 2. That the ordinance provide that the manager may be discharged by action of the President and Board of Trustees acting jointly, instead of by the President, with the requirement that that discharge be reported at the next meeting of the board of trustees.
- 3. That the acting manager be appointed by the President and board acting jointly, instead of by the Village President, as the ordinance now reads.

The positions of health officer, superintendent of public works, building inspector, plumbing inspector, electrical inspector, and superintendent of the sewer plant are now made offices in the code of 1957; and you ask that a companion ordinance be prepared which would amend the 1957 code to make these positions of employment rather than offices, so that the manager would have the right to appoint the heads of each such division. That is within the powers of the board.

It will not be possible to have the ordinance redrafted with these changes in it by Monday; perhaps there will be other changes suggested by other trustees, and they can

- (4) If the city or village was subject to the aldermanic form provisions of Article 3<sup>1</sup> at the time of adoption of this Article 5 to appoint and remove all officers who are not required to be elected by Article 3;
- (5) To have all the powers and exercise all the duties granted elsewhere in this Code to municipal clerks and comptrollers with respect to the preparation of a report of estimated funds necessary to defray the expenses of the city or village for the fiscal year for the consideration of the corporate authorities prior to the preparation of the annual appropriation ordinance;
- (6) To attend all meetings of the council or board of trustees with the right to take part in the discussions, but with no right to vote;

4.909 Budget.) On or before May fifteenth of each year the manager shall submit to the corporate authorities a budget, including information as to all anticipated revenues of the village and a detailed list of the anticipated expenditures for the current fiscal year.

The information contained therein shall be available for the preparation of the annual appropriation and tax levy ordinances required by law.

4.910 Reports to the corporate authorities.) The manager shall report to the president and board of trustees each month, or more often if required by them, the financial condition of the village, bills, payroll and other obligations then due and payable.

4.911 Hours of duty.) The manager shall devote his full time to the performance of his duties and shall not engage in any other employment without the consent of the board of trustees.

4.912 Cooperation with other officials.) The manager shall cooperate with and assist the village treasurer and village clerk in the performance of the duties imposed on them or delegated to them by law.

DEERFIELD IS A LEADER in the home building field in the Chicago area and is so reported in the Bell Savings Survey of New Building. April was the second month of 1964 where the value of permits taken out for new homes topped \$1,000,000. The average cost per home at \$33,608 was the highest in the entire Chicago area. WORK IS UNDERWAY on the Conifers Special Assessment by Meyer Construction Co.. This will make the residents happy in this area as they have been disturbed with the dalay caused by the Spring rains. Here is one more step toward the realization of finer Deerfield.

THE SEWAGE TREATMENT PLANT will be visited by the President and Trustees of South Elgin this coming Sunday. They are planning to construct such a new facility and wish to see what a fine plant looks like.
