Would you please review such applications to see if you come to the same conclusions? In order that we may then move the matter to a successful conclusion as soon as feasible, it is suggested that we have a committee of the whole meet on Wednesday, September 16, and invite Messrs. Keaton and Schertz and a committee of the whole meeting on Thursday, September 17, and invite Messrs. Gaffigan and Johnson.

It is suggested further, that we authorize Mrs. Pinkerman to invite these people by telephone (person to person), rent two rooms at the Motel in Barrington, on Wednesday and Thursday nights, pay each applicant \$20.00 (\$10.00 for each of two days) plus airplane fare (tourist class) and prepare such checks for delivery at the time of the applicants' visit.
