Meeting called to order by President John H. D. Blanke. At roll call Trustees present: David R. Capulli, Robert F. McCaw, Robert J. Long, Paul J. Shultz, J. Frank Wyatt. Also present: May L. Pinkerman, Clerk; B.J. Zelsdorf, Treas.; S. Axelrood, Attv.

PRAYER: Eulogy to late President John F. Kennedy given by Rev. Eugene Nyman of Barrington Community Church, followed by moment of silent prayer. After prayer by Rev. Nyman he read an "In Memoriam" prepared by President Blanke. Later:Trustee Long MOTIONED that a copy be prepared in proper form, signed, sealed and forwarded to Mrs. Kennedy. Seconded by Trustee Wyatt. Ayes.

LIST OF TOPICS for this meeting distributed by President.

MINUTES of 11-12-63: Page 4 - Par. 6: Trustee Long to be shown as Chairman of the Architect Selection Committee. With this addition minutes approved on MOTION by Trustee Capulli, seconded by Trustee Wyatt. Ayes. Trustee McCaw not voting a/c absence from that meeting.

INQUIRIES FROM FLOOR INVITED: No response heard.

WELL #3-BIDS: MOTION by Trustee Long that Village Clerk open & read bids received for boring of Well #3, 2nd by Trustee Wyatt. Ayes.: Layne-Western Co. of Aurora, Ill., base bid = \$16,738. - noted that bid check for \$840. not attached or received. J.P.Miller Artesian Well Co., Brookfield, Ill. base bid = \$15,420., M.O. attached for \$775. Trustee McCaw recommended that bids go to Engineer Lewis for checking and recommendation tonight.

ILLINOIS REVISED STATUTES: Clerk authorized to purchase 2 sets for Village Hall & Police Dept. use.

JUSTICE OF PEACE COURT: President noted Cook County will pay rent for Dec. & lease will not be in effect thereafter, per written advice. In order to aid in retaining Court here President authorized taking of 3 photos of Council Chambers to prove to court system there is adequate space, hoping they will approve use for continued purt purposes. Photos displayed. Bill for same to be on next list. Justice of Peace Haggenjos will deliver original photos.

BARRINGTON AREA UNITED FUND DRIVE COMMITTEE: President appointed Trustee Wyatt as alternate delegate to Trustee Long, Board representative. MOTION to concur by Trustee Shultz, seconded by Trustee Capulli. Ayes.

CHURCH DIRECTIONAL SIGNS: 4 signs requested by Evangelical Free Church for various locations, to measure 15"x20". Discussion had. President has contacted State Highways Dept. learning there is strict law governing signs on State Highways or on approaches to same. Chief Muscarello quoted from 1963 revised statutes. Trustee Capulli suggested granting permission subject to their getting State approval. Trustee Wyatt suggested they be referred to State and felt there are a great number of church signs on corners - perhaps too many at this time. Chief of Police noted some have gone up recently without permission. Trustee Wyatt believes matter should be studied and policy set up. After considerable discussion MOTION by Trustee McCaw that this matter be referred to Street Committee for study and report back. Second by Trustee Capulli. Ayes. Opposed: Long. Data to be sent Trustee Wyatt. Trustee Long suggested Ministerial Assoc. may desire to get into this with Committee. President noted in some areas a sign appears in downtown section listing locations of all churches in community.

HIGH SCHOOL REQUEST: Sophomore Class has requested permission to set up beverage stand during Christmas season to dispense hot drinks to raise money for March dance; in downtown area. Trustee Capulli read letter and desires further information as to where, hours, insurance, traffic, parking and further noted Village health standards must be met, including disposal of waste. At this point Trustee Long questioned inspection of dispensing of food &/or beverage at high school meets, etc. Mr. DeJonge to be consulted. Letter directed to Committee Chmn. Sophomore Class.

HOME BLDRS. ASSOC.CHGO.SHOW: Bldg. Commissioner authorized to attend if so desires.

CUMNOR AVE. IMPROVEMENTS (Rieke Cons. Co.) President noted they put in water, sewer, paving improvements on Cumnor & Home Aves. Trustee Wyatt read letter of 11-18-63 from Consoer, Townsend & Assoc. recommending Village accept improvements following with MOTION that Village so accept improvements for sewer, water and paving on Cumnor & Home Aves. as set forth under CT&A 63-055. Second by Trustee Capulli. Roll Call-Ayes: Capulli, McCaw, Long, Shultz, Wyatt.

FLASHING SIGNS: 2 legal interpretations of various ordinances read, - existing signs, under question, not considered in violation.

#3 WELL BIDS: Mr. Lewis reported to Board bids are in order with exception that no check was found attached to Layne-Western bid, suggesting they be notified immediately. He stated low bid is in order and contractor reliable. Chairman noted funds are on hand. MOTION by Trustee Wyatt that we accept bid of J.P.Miller Artesian Well Co. of Brookfield, Ill. for Water Works Improvements Division A-Well #3 in amount of \$15,420. Second by Trustee Capulli. Mr. Lewis stated that, if motion is passed, he will prepare necessary contract for processing by contractor and furnishing of bond. Motion automatically authorizes President & Clerk to sign on behalf of Village; tabulations to be sent to Clerk and both bidders - Lewis. Roll call-Ayes: Capulli, Long, Shultz, Wyatt. (Cert.chk.rec.11-26-63 - Layne Western) McCaw,

PUBLIC WORKS BLDG. Plumber's contract not yet finished out.
" " Equipment:purchase to be deferred until after recess-Tr.Shultz.

WELL #3: J.P.Miller Artesian Well Co. representative thanked Board for contract stating they are boring in Palatine and should be here in about 2 weeks. FINANCING: Trustee Long stated he and Treasurer met with Auditor Kelsey last week to determine size of bond issue necessary. Total estimated cost \$388,000 plus cost of retiring bonds under ordinance #246 of \$45,000. totalling \$433,000. Further details noted by Trustee Long, and discussion had with Mr. Lewis re Depreciation Fund Ordinance. Attorney Matthews has requested a luncheon meeting conference downtown with Trustee Long, Treas. Zelsdorf and Mr. Kelsey, within next few days. When date is set Trustee Long will notify others. It was felt if meeting held this week Bond Ordinance could be prepared about middle of December. MOTION by Trustee Long to authorize Attorneys to draw Bond Ordinance for issuance of Revenue Bonds in connection with proposed Waterworks Improvements with amount of issue and maturities to be left blank until such information is definite. Second by Trustee Shultz. Roll call-Ayes: Capulli, McCaw, Long, Shultz, Wyatt. Trustee Long asked President if he would kindly draft information on history of waterworks system for possible brochure use.

METHOXYCHLOR PURCHASE & TREE PLANTING PROGRAM: Trustee Wyatt reported a Committee Meeting set for 12-2-63 at 8PM with Forestry Committee and all Trustees, also Mr. Roth.

121 & 127 W. STATION ST.: PARKING FACILITIES: This matter discussed at last meeting. President suggested a more definite policy be set up for Department Heads to follow.

Cars parking on lots now, free of charge, taking revenue from Village Parking. Discussion had during which Trustee McCaw stated he could not understand keeping lots vacant, until we make disposition either by paving lots and putting in meters or building, why not accommodate some of the merchants in the area. It was noted some commuters have been using lots. It was decided to have Police Department control area with cars to be identified. MOTION by Trustee Capulli that any business house in this immediate area that wishes to park on that Village property, adjacent to wells, be granted permission with fee to be \$5. per car per month—cars to be identified for Police Department, immediately. Second by Trustee Shultz. Number of stalls available to be set by Police Dept. and it was stated this is a temporary arrangement. Roll call-Ayes:Capulli,McCaw,Long,Shultz,Wyatt. A "restricted parking area" sign to be erected.

JEWEL PARK ELM RD. LIGHTING REPAIRS: President reported that Carl Bowen of Consoer, Townsend & Assoc. was here Saturday, meeting with Supt. Johanesen; there are 2 circuits in Jewel Park from 1 regulator in a vault and 36 lights are dead. Mr. Bowen advised that, if Board authorized advertising for bids tonight for issue of 12-5-63 bids could be opened 12-9-63. This was considered too short a time allowance. It was suggested next meeting might be adjourned to Dec. 16th. Finally decided that if notice is received by Dec. 2nd could be published Dec. 5th. Estimated cost to be \$10,000. MOTION by Trustee Wyatt to authorize publication for bids for Jewel Park Lighting Improvements in accordance with specifications to be submitted by the Engineers. Second by Trustee Capulli. Roll call-Ayes: Capulli, McCaw, Long, Shultz, Wyatt.

ARCHITECTS SELECTION COMMITTEE: Trustee Long called meeting for 11-30- at 10AM. Police & Fire Chief should be present; later changed to 12-2-63 to follow other meeting planned for that evening.

BILLS: After short discussion MOTION by Trustee Long that bills be paid from funds indicated, seconded by Trustee Wyatt. Roll call-Ayes: Capulli, McCaw, Long, Shultz, Wyatt.

SCHOOL AREA SIGNS - GROVE AVE., HILLSIDE, ETC: Traffic check made by Chief Muscarello; Trustee McCaw read letter-report. Cook County is cooperating with Chief and will install white pads in Spring - Chief requested that streets be marked with white lines in interim at Grove across Hillside and Illinois across Grove by Street Dept. Ordinance read by Trustee Capulli, followed by discussion. MOTION by Trustee Capulli to adopt ordinance seconded by Trustee Shultz. Roll call-Ayes:Capulli, McCaw,Long,Shultz,Wyatt. (LATER: to be re-drafted a/c Yale Aye. was included.)

CHICAGO AERIAL INDUSTRIES: No reply received from State on request for traffic control.

REFUSE & GARBAGE CONTRACT RENEWAL: Trustee McCaw reported he and President met with representative of Barrington Trucking Co. & they (BTCo) were negotiating with union. Village has not increased charges to customers in 5 years of contract and it was noted Barrington Trucking had not for 3 years prior to that time. Discussion had. Barrington Trucking Co. letter of 11-8-63 read; Trustee Capulli suggesting holding matter until next meeting and Attorney received copy of contract from Trustee McCaw. Trustee Wyatt suggested no change in rates until after union negotiations of the Contractor culminated and Village Board notified.

BURNED MOTEL BLDG.: Matter still within 30-day period - Trustee Shultz.

SIDWELL MAPS: Chairman noted he has requested cost for updated sheets for our books.

STREET & BLDG. USE MAPS: No further report; committee asked to meet with President & Clerk on this.

VILLAGE HALL-1st FLOOR REMODELLING: After examination of space to become available including old meter room, Trustee Shultz felt entrance to that room could be supplied thru the brick wall in present storage section and rear door can be improved for better security. Supt. Johanesen to get some estimates on this and report for next

MUNICIPAL VEHICLE: To be further discussed at Committee of Whole meeting 12-2-63.

CONNECTION CHARGE ORDINANCE: Trustee Long briefed on proposed watermain extension in Glendale from Harriet Lane to Warwick Ave. also extension on Eastern Ave. Engineers estimate, per letter of 11-14-63 for 6" watermain on Glendale was \$2800.

DECEMBER 23rd MEETING close to Christmas Eve & meeting date to be discussed 12-9-63.

CURB & GUTTER REPLACEMENTS: Trustee Wyatt reported on bids referred to Street Comm.;-Etters Improvem.Co. 85¢ per sq.ft.; English Const. Co. 87¢ per unit ft. for sidewalk and \$3.00 per lineal ft. for curb & gutter from Etters; \$5.60 per unit ft. from English Cons. Co. MOTION by Trustee Wyatt that proposal from Etters Improvem. Co., for prices in accordance with their bids be accepted in respect to this repair work & as opened and read at last meeting. Seconded by Trustee Shultz. Roll call-Ayes: Capulli, McCaw, Long, Shultz, Wyatt.

STREET LIGHTS-S. HOUGH ST.: Trustee Shultz reported additional lumens, etc. have been installed on S. Hough St. south from Lake St. However, 1 light recommended for opposite Library driveway and exit on Hough St. between Monument and Sturtz Sts. MOTION by Trustee Shultz that this light be added at that location and that we request P.S.Co. to complete with lumens as they recommend. Second by Trustee Wyatt. Roll call-Ayes: Capulli, McCaw, Long, Shultz, Wyatt.

HUMAN RELATIONS: Trustee Long noted that Editor of Barrington Courier Review sent request to President asking that a delegate be appointed to an areawide human relations Committee, opening matter for discussion. President stated he does not feel there is a need for Board to name a delegate to such a commission; we have a Police Dept. that can take care of any matters that might occur and, further, does not feel Village Board should dispense any of its authority to others. Trustee Wyatt would like someone to study pros and cons of this and what is to be accomplished - the real purpose of it. Chief Muscarello stated if his Department should be too small in case of trouble he would call Counties and State Police if it had to be. President stated he was not ready to make recommendation tonight. After a heated debate Trustee Capulli suggested matter be put on agenda for next meeting.

POLICE DEPT. VERIFAX MACHINE: After presentation, MOTION by Trustee McCaw that purchase of 1 Actimeter Unit be approved at cost not to exceed \$80., seconded by Trustee Capulli. Roll call-Ayes: Capulli, McCaw, Long, Shultz, Wyatt.

RALPH STOETZEL SKETCH: Received via Trustee Capulli tonight covering suggested alternate traffic plan at C&NWRR depot; to be checked by Trustee McCaw and Chief Muscarello with recommendations to Street Committee. (on file with Clerk)

MEETING ADJOURNED at 11 PM on MOTION by Trustee Capulli, second by Trustee Wyatt. Ayes.

T. & A. No. 63-196 Gentlemen: In accordance with your action of September 9, 1963, we have prepared improvement plans for Parking Lot No. 2 south of the Chicago and North Western Railway. We are enclosing for your inspection and approval two sets of plans, consisting of five sheets, and estimate of construction cost dated November 27, 1963. The improvements shown on the plans (see Typical Cross-Section of Sheet 3) indicate a widening along the south side of the railroad embankment, the construction of an 8" gravel crushed stone base course thereon, and the surfacing of both the existing and widened portion with a 2-1/2" bituminous concrete binder and surface course (I-11). The plans further encompass the removal and the re-erection of the existing steel guardrail as well as the removal of the gate mechanism. Due to the widened paving area, a new staircase is required between Parking Lot No. 2 and Parking Lot No. 1. A cross-section of this staircase is shown on Sheet 3. Sheet 2 indicates a striping plan. You will note we have left unchanged the arrangement of the existing wheelstops immediately adjacent to the railroad, except that we have added additional parking opposite the entrance to the parking lot and at the southeasterly end. The detailed estimate of construction cost indicates a total improvement cost of \$22,987.80. This cost estimate does not include the purchase and installation of the required number of parking meters. Work shown on the drawings submitted will be constructed in compliance with the standard specifications for Road and Bridge Construction, Illinois Division of Highways, adopted January 2, 1958, and supplement specifications effected April 2, 1962. Dear Mr. Wyatt:

On October 29th I met with the Forestry Committee as you suggested. They were non-committal on the reforestation program. I believe this attitude stems from the fact that no one has acknowledged their letter of recommendations to the Village Board of March 25, 1963 after they spent the time and effort on the outline.

With the Village Board to be meeting soon, I shall try to present a few generalizations covering some of the items in their March 25th letter, some highlights of parkway work accomplished this year, and some existing problems so as to familiarize you with the immediate situation.

All of the parkway elms are, of course, susceptible to Dutch Elm Disease. the elms, about seven out of ten have wet wood disease. We lost none of the 50 parkway elms on Elm Rd. which were experimentally injected the past two years with SD 3562 (Bidrin) nor none of the 50 control parkway elms. Last year after injection, about half of the elms showed phytotoxicity with varying degrees of foliar damage. After sending my SD 3562 data report on Barrington to Dr. Dale Norris, head of the Dept. of Entomology, Univ. of Wisconsin, who heads this research program, he advised cutting the next dosage in half for those trees which reacted adversely. His research program is on a vast scale including many states and therefore many trees. When I recently attended Wis. State Dutch Elm Disease Conference and talked to Dr. Norris about Barrington's experimental elms, he advised me to each year cut the injection dosage for any tree which showed toxic symptoms. The difficulty, he says, in stabilizing the dosage is because elms are as variable as humans and react individualistically. After altering dosages this Spring, only injected elms numbers 4, 5, 6, 7, 8, and 30 showed adverse symptoms.

Since SD 3562 is being put out by a California company in a new type of self activating capsule, it is being accepted for use with great regard although these units are as yet on an experimental permit basis only, but approved by the United States Dept. of Agriculture. This improved technique causes much less damage to the tree at the site of injection and is less hazardous to the operator administering the treatment. Although Bidrin has some imperfections preventing it from being commercialized yet, I feel confident in the acquired knowledge I have of it to suggest that any parkway elms not sprayed at request of homeowners be injected with this product as a prevention against Dutch Elm Disease.

Under the aegis of Drs. Himelick and Neely of the State Natural History Survey in Urbana, Illinois, we have, during this Dutch Elm Disease season of 1963. chemically trenched with Vapam 507 feet of parkway. As a soil sterilant. Vapam kills the roots where injected so as to prevent the fungus traveling from a diseased to a healthy elm. Drs. Himelick and Neely state that a diseased elm within 30 feet of a healthy elm is 80-90% sure of infecting the adjacent tree through root graft. Dr. Norris says that Dutch Elm Disease root grafts underground is a big factor in spray programs being disparaged. Statistics prove that nearly half of occurring Dutch Elm Disease has been contracted from underground transference through root grafts. Drs. Himelick and Neely have Barrington's data on Vapam and results of their research will be known next summer.

In Jewel Park, Pin Oaks are dying from advanced chlorosis. Parkway sycamores have had repeated attacks of anthracnose. Many years the soft maples on the parkways are infected with cottony maple scale. There are control measures possible for treatment of all of these conditions.

Many of the Norway, Schweidler, and Sugar Maples on the parkways are very low branched. This summer, while trimming to make clearance for vehicular traffic, we encountered difficulty in making clearance without spoiling the shapes of the trees. The large parkway evergreens presented even more of a problem.

In the Village parkway reforestation program, besides determining the kind of tree best suited for an intended planting site in relation to its surroundings, many other details will have to be resolved. Decisions will have to be made regarding staking the chosen planting site, trunk diameters, size of burlapped ball. price including shipment to job site, stock guarantees, planting and fertilizing mix to be used during planting, the hauling away of sub-grade soil, wrapping of trunks, subsequent watering and fertilizing, etc.. Definite specifications should be listed for bidders for the nursery stock and for the planting contractor.

As a general guide in choosing the kind of trees for parkway planting, Skokie and Chicago Forestry Dept. are planting Sugar Maple, Honeylocust, Green Ash, Norway Maple, Silver Maple, and Sycamore. I'll find out what kinds Palatine and Arlington Heights have chosen to plant.

Buying in quantity (5 to 24 of a kind), sighting you an example of costs from a wholesaler's book, the following cost list is for 13/4--2 inch trunk diameter trees with a 22 inch burlapped root ball and my approximation for the planting charge:

I might state here that as an arborist with considerable experience, I am capable and willing to perform any of the services outlined in the Forestry Committee's March 25th letter. Some we are already engaged in doing for the Village but I am also equipped to conduct a complete survey, liquid fertilize trees, administer insect and disease control, and conduct a reforestation program.

As for their Article II in the Forestry Committee's letter concerning specific recommendations being made to the Village Board after the survey is made, I believe they have in mind that it should be done by such a firm as William Rose and Associates who specialize in City Planning of Streets.

An Open Letter to the Barrington Village Board.

I wish to express my concern at the attitude of several Village Board members and the Mayor to the proposal of appointing a representative to the Civil Rights Policy Group.

Although I am not a legal resident of the Village of Barrington I am very much involved in its affairs, just as surely as Barrington is involved in the affairs of this nation.

Of course a Civil Rights Policy Group is not the entire answer but it is a constructive beginning to a recognition of the problem of discrimination. This recognition by you, as elected officials, is part of your responsibility to the people of Barrington as well as to the nation.

We do not have a "negro" problem in Barrington because the racial barriers built around our community have been strong and effective. Are we content to live with this situation? Have we not learned that discrimination and prejudice breeds hate and that hate goes hand in hand with extremism? Was not the murder of John Kennedy worth more than the passing of a resolution? Words are cheap and easily forgotten. Resolutions are hollow and useless unless coupled with the courage to act.

Our Village of Deer Park, I am proud to say, not only appointed a member to this policy group but also set up its own Human Relations Commission in order that our Village mught become involved and meet its responsibilities. This was done a week before the Presidents death and, as one Board member commented, what better tribute could our Trustees have paid to Mr. Kennedy.

I submit that if your Board was sincere in the passing of that memoriam resolution you will appoint a member to the Civil Rights Policy Group and furthermore will take immediate steps to set up a Human Relations Commission to learn the real extent of prejudice and discrimination in this area.

The people of the Barrington community have a responsibility also and I would hope that every concerned citizen would be at the next meeting to encourage and support the Board in this action.

We can no longer afford the luxury of doing nothing.
