Minutes of Special Meeting of the Session held March 19, 1962

A Special Meeting of the Session of The Presbyterian Church of Barrington was held at the Manse, 808 Lill Street, Barrington, Illinois, on Monday, March 19, 1962, at 8:00 o'clock P.M., pursuant to written notice from the Pastor.

Mr. George Gruendel, Chairman of the Building Committee, was present by invitation.

The meeting was opened with prayer by The Reverend Winchester.

Charles Boand brought up the question of the proposal of the Presbytery of Chicago for the creation of a committee to participate in a self-study group. It was the consensus of the meeting that no action should be taken on this matter.

George Gruendel presented to the Session a report of the Building Committee. A copy of the report is included in the minute book following these minutes.

On motion of Charles Boand, seconded by Norman Tucker, the following resolution was unanimously adopted:

RESOLVED, that a meeting of the Congregation is hereby called to be held pursuant to written notice at the Countryside School,

Barrington Hills, Illinois, immediately following the Sunday service on April 1, 1962, for the purpose of considering and acting upon a revised and increased Church construction program and a revised and increased construction budget and financing program.

Norman Tucker then moved that the Building Committee report be received, approved, accepted and presented to the Department of New Church Development of the Presbytery of Chicago. The motion was seconded by Jack Train and unanimously adopted.

The meeting was duly adjourned at 10:25 P.M. with prayer by The Reverend Shangler.
