A Regular Meeting of the Session was held at the Manse, 808 Lill Street, Barrington, Illinois, on Monday, December 3, 1962, at 8:00 o'clock P.M.

Reports of Committees

Worship Committee --

Carl Knipp advised the Session that he would prepare an invoice to cover services of John Gardner rendered on two Sundays, plus a \$10.00 gratuity for Christmas, to be paid during December.

Stewardship Committee --

Norman Tucker reported on the spiritual audit and gave various statistics in respect of it. He also announce that, as a result of the Every-Member Canvass, to date 74 pledges had been obtained to the Operating Fund aggregating \$20,996.00, an average of \$283.00 per pledge. He stated the stated that had been made to date. 20 of the persons called had not pledged. Reports have not yet been received in respect of 51 calls scheduled to be made. About 80% of the persons called upon have made pledges. Projecting the response the entire canvass on the basis of the calls reported upon the date indicates that the total amount pledged will be about 32,000.00. In addition to this, of course, several thous of dollars will be obtained during the year from the loose offerings.

RESOLVED, that the Annual Meeting of the Congregation be held at 7:30 o'clock P.M., on Tuesday, January 15, 1963, at the Countryside School in Barrington Hills, Illinois.

The question of a Special Christmas Offering was discussed, and, on motion of Norman Tucker, seconded by Jack Train, the following resolution was unanimously adopted:

> RESOLVED, that the Pastor send to the Membership envelopes for a Special , Christmas Offering, the proceeds of which are to be contributed to Benevolences.
