IT IS GOD'S WILL FOR OUR CHURCH? This question should be uppermost in our inds as we plan and carry out the daily activities of our church, as well as men we contemplate expansion of our program and service. The following mentary appeared in the bulletin of the First Presbyterian Church of thata, Georgia, on August 1, 1965:

"Seek God's will for your church . . . only God knows exactly how your church stands in its relationship to His will for it. Only God knows exactly what are the opportunities your church has for service. And only God knows whether or not your church is fully measuring up to the opportunities He gives. So we must each seek to know God's will for our church, and try to help our church serve His purpose, not our own ends.

We must seek God's will for the relationship of our church and its community. We must seek His will for the relationship that should exist within the church among the members. We must ask God's guidance in our building and expansion, and in our budgeting. We must seek God's will for our service through our denominational and interdenominational agencies.

"And when we find God's will we must try to find all of it. We should not ask Him to tell us what is the bare minimum our church can do for His kingdom, and still get by. Seek to know all we can do. Ask God what is the most we can do, and humbly ask God to help His servant accomplish this task: Seek His will, and seek to do it.

"We share a great commission, and a holy calling to "Go and Tell." We are partners with God in a great enterprise which cannot fail, for God will eventually have His way. What a thrilling thought it is when we realize completely that God's will includes our lives, and that He has asked us to share in His work!"

AS OUR CHURCH SCHOOL GROWS, the duties of the superintendent increase. The Christian Education committee, therefore, has decided to "spread the work" by appointing an Administrative Superintendent who will be aided by several assistant superintendents, one for the 9:30 a.m. Church School, one for the 11 a.m., and at least one other to supervise high school and adult Christian Education programs.

Charles Barner has been named as the new Administrative Superintendent. Mrs. Dorothy Ruge, who has been working long hours organizing the Church School this fall, continues as an Assistant Superintendent. Other appointments will be announced later.

Attendance on Sunday, October 31, was 56 children at the 9:30 a.m. Church School and 57 at 11 a.m., and it is increasing:

She will return on November 14 to lead the junior department at 9:30. We are grateful for her advice and assistance in trying to improve our teaching program.

"REVOLUTION IN RELIGION" is the subject of the next program in WBBM-TV's award-winning series, "I See Chicago," at 9 p.m. Sunday, November 7, on Channel 2. The program will take a close look at religion's attempt to adapt to the needs of modern man, with graphic examples taken from Chicagoland areas. Included will be scenes of a "night pastor" whose congregation consists of bartenders and musicians from the Rush Street and Old Town night spots, guitar-playing, folk-singing nuns, and a white Fundamentalist preacher who uses street-language vernacular to communicate with his teen-age Negro members.

A special feature of the program will be a Feedback survey at the conclusion of the broadcast to determine the viewers' attitudes on religion today.
