Errors Contributed Greatly to Togo's Decisive Vistory.

A Freuch naval officer has been abtempting to explain the collapse of some of the Russian line of battle-ships in the fight in the Sea of Japan. He said that, from their design, a number of ships had only a moderate degree of stability.
