State Convention of Miners Has  
Been Postponed.

SESSION ON FEBRUARY 24

Change is made to accommodate Dr. McDonald, Secretary-Treasurer, who will be in Philadelphia on the 17th.

Springfield.—It was announced at the state miners' headquarters in Springfield that the convention scheduled for February 17 at Peoria has been postponed to the 24th.

The change of meeting is to accommodate Dr. McDonald, secretary-treasurer of the State Federation of Mine Workers, who is called to Philadelphia, where a joint conference of operators and mine representatives will be held beginning February 27.

John Lord, vice-president of the mine workers, stated that the attempt of Illinois representatives at the conference at Philadelphia will be to secure a uniform agreement throughout Illinois, Indiana and Ohio and west Pennsylvania in order to put the mine of this locality on an equality.

It is the opinion of the state mine workers that the operators in the Illinois coal fields are anxious to avert a suspension of business because of the shortage of work during the present winter.

The Illinois mine owners are expected to offer opposition to any movement that will precipitate a general strike.

The demands that the miners will make are an increase of the rate of pay on mine run working basis, a uniform working day and a uniform scale.

It will be necessary for the operators of the four states represented to come to some sort of an agreement among themselves at Philadelphia before they can meet the miners, and trouble may arise in the operators' conference before the joint conference is called.
