## HOWARD HUTCHINSON IS INSTANTLY KILLED

Was Working for the Chicago Telephone Company at McHenry—Messenger Wire Cables Pole to Break

### WAS PROMINENT YOUNG MAN

He was Born and Raised in This Village—Had Many Friends Here—Family is Mournful

We are called upon this week to recount the sad death of Howard Hutchinson, who was killed at his work for the Chicago Telephone Company, McHenry. He was employed as a messenger wire cables pole to break. He was a prominent young man, born and raised in this village. He had many friends here and his family is mournful.

When the pole broke it snapped the safety belt which he had around him and the pole. The giving away of the pole and the recoil of the messenger threw Howard about 30 feet away from where the pole stood. He struck on his head which was badly crushed and nearly every bone in his body broken.

A sister's layette was held at McHenry at five o'clock Monday evening and the body brought to Barrington early Tuesday.

Howard Lee Hutchinson was born in Barrington, Sept. 22, 1891, being at the time of his untimely death, 22 years, 10 months and seven days old. He was a prominent young man, born and raised in this village.

He was survived by his mother, four sisters and two brothers. They are Mrs. Richard Barker of Chicago, Mrs. Norton D. Brown of Barrington, and Miss Fern Hutchinson and Mrs. Vincent Davlin of Waukegan and Charles and James Hutchinson of this village.

## PAY \$20,000 FOR A HOLSTEIN BULL CALF

Four Barrington Men Buy High Calf in Chicago at Auction—Price is a Record Breaker

### ANIMAL IS ONLY FOUR MONTHS OLD

Spencer Otis, Sr., Spencer Otis, Jr., George E. Van Hagen and H. Gillson Hart are the purchasers.

Four Barrington men Friday purchased a bull calf at the public auction of the Western Breeders' Consignment Co. at the Union stockyards, Chicago, for \$20,000. It is the highest price ever paid at a public sale for a dairy animal.

The calf is a descendant of one of the most productive families of that breed in the world. It is a son of Illinois and is called King Segis Pontiac Chicago.

The calf was born on February 25, of this year. Auctioneer Kelly started the bid rolling with a bid of \$10,000. Several groups congregated and the price was placed at \$11,000.

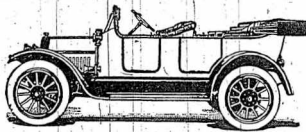

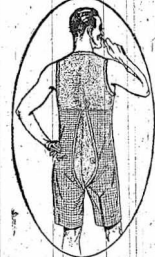
