THE FARMERS AND FOOD CONTROL.

An illuminating side light on the food situation is contained in some expressions inserted in the Congressional Record recently by Senator Smith of Michigan. These were from farmers' organizations and individual farmers, and they without exception demand the food control measures proposed by Congress.

These expressions give us a pretty clear idea as to whence come the present panic prices. We are told with greatunction that this is the first time in our history that the farmer has received for his products what they were really worth.

But let us see. What is the object of food control? Whence comes the insistent demand? Plainly, the demand is the direct result of food prices that are out of all proportion to wages and to prices in every other line. It is demanded to bring it about that farmers were receiving a fair price for their products—fair price meaning, of course, a reasonable percentage of middlemen's profits—that they would be not only willing, but anxious to kill the goose that lays the golden egg?

The plain truth is, the farmer is not benefited by the present high prices of food in any degree to recompense him for what he is injured by extravagant prices in other lines. He is paying vastly more for every purchase he makes, from a plow point of a trifle, to the time when he gains a small profit on his highest food purchases, more than offset by the enormous increase in the cost of everything that he must buy to operate his farm. This the farmers know, and this is why they are, almost without exception, heartily in favor of Government food control—a control which will establish a minimum as well as a maximum price.

The speculating food pirates will have to hunt some other scapages for their sins instead of the farmer and his "interests."

This idea of protection of our soldiers has been further enlarged, as Secretary McAdoo now proposes life and disability insurance for the men who go to the front, and adequate provision for the support and care of their dependents. The conference held in Washington lately with representative insurance men of the country, and it seems that this insurance will be done by the government and will not be done by private insurance organizations. Here is another wise and just use of Government funds that will meet with the approval of the nation.

In a speech before the conference Secretary McAdoo in part said: "It is a crime for a great nation to take a man and send him to fight for his country, and to refuse to make adequate provision for the man and those who are dependent upon him and leave them possible object of the charity or generosity of their neighbors."

"We must see to it not only that every American soldier is equipped with the best that American money, ingenuity and skill can provide; in order that he may fight with the utmost effect and sell his life as dearly as possible for his country, but we must see to it also that every American soldier shall go to the front with the confidence and assurance of his family that his loved ones will not be dependent upon him, but that they are as much entitled to compensation for what they are sacrificing in order that he may go to the front as he is entitled to compensation for what he does at the front."

OUR FINANCIAL STRENGTH.

Two billion dollars is a tremendous sum of money. Yet the American people have loaned their Government that much and have barely touched their resources. The money was raised so easily it only seemed to show the tremendous financial strength of the country.

It is not unusual of our national deposits. It is less than one-eighth of our bank loans for one year. It was less than one-half of our national savings for 1916 and only five per cent of our national income for that year, according to estimates.

Not only is this first Liberty loan bond issue of two billion dollars much larger than the initial loans of any of the other nations engaged in the war, but it was raised in much less time, with much less effort, and was subscribed by a vastly greater number of individuals; this, too, without loans from far and near the nation in a calm frame of mind.

The coming second issue of Liberty loan bonds, with the great mass of the people of the country much better educated as to Government bond issues and Government finances in general, it is reasonable to suppose, will be disposed of with even greater success than the initial issue.

The oversubscription to the initial issue of over a billion dollars augurs well for the success of the next loan, especially when the second issue in Government bonds in America there were a month ago. Then there were some three hundred thousand holders of United States bonds; now there are over four million. And the thrill of the thought of our soldiers in France will rally the people to the nation's call.
