#### FARM AND INDUSTRIAL STRIKES

Human nature is hard to understand.

Some observers always sympathize with coal miners, shoremen, steel mill workers, railroad trainmen and other groups of artisans when they strike for higher wages but condemn the farmer for withholding his milk from mar-ket when he is not paid the cost of producing it.

Any group has the right to strike but has not the right to force men outside its group to quit work or withhold its produce from market. In this respect we notice that the leaders of the milk strike apparently have made sincere ef-forts to win dairy farmers to their cause by persuasion. We do not believe the majority of farmers are in sympathy with rs who destroy property and du milk. At any rate there is no more, if as much, this strike than in the ordinary industrial tie-up.
