Miss Emily Resek of Cary received lacerations about her face, bruises and shock. Decision Handed Out on Bond Case in Court Friday

Village Cleared of Liability for Over-Insurance by Master's Decree

At a special board meeting Tuesday evening Earl Hatje, village president, read a report from T. D. Maloney, village attorney, on the disposition of the Kuckack versus the village of Barrington case handed down in the circuit court of Lake county Friday. Master of Chancery Albert Hall entered a decree covering all special assessments bonds of the over-insurance.

This decree covers bonds in question in special assessment proceedings numbers 23, 24, 27, 28, 30, 31, 32, 33, 37, 39, 41, 43, and 51. The rights of all parties were fixed and determined in the order and decree. Barrington was not liable for the over-insurance. Three-quarters of the cost costs, or \$291.75, was assessed against the property owners.

Following is a summary of the court's decision on certain bonds in question in the various special assessment warrants:

"A bond purchased by E. F. Bryant from the First State bank was declared invalid. A \$500 bond purchased by Fred Kuckack was void. Two \$500 bonds held by Henry F. Miller were held to be in part and permitted to share a portion of the assessments levied. Two \$500 bonds purchased by Charles Wewetzer and H. F. Miller were void. Two \$500 bonds purchased by Mary Riley from the First State bank were held to be partially valid and permitted to share a portion of the assessments levied. One bond purchased by Mary Riley from the First National bank was held void. Three \$500 bonds purchased by Henry Lesberg from the First State bank are partially void and share a portion of assessments levied. On this same proceeding bonds 325, 326 and 327 were held void.

The public will have an opportunity to inspect the construction of the building trades class of the local high school when the Cape Cod residence, built by the school classes on Liberty street is thrown open to visitors Saturday afternoon from 1 to 4 o'clock and Sunday afternoon from 1 to 4 o'clock.

The home, a frame structure of five rooms and bath with provisions for additional rooms, was built under the direction of Charles H. Roselle, class instructor, for Earl M. Schwemm. Mr. Schwemm purchased the materials and the class worked for the practical experience.

At present 29 boys are actively engaged in the construction work. When the building was started last October the class numbered 32. The building had progressed sufficiently by the end of the year to allow a classroom to be set up and classes were held there each day. The boys were divided into morning and afternoon groups and spent three hours each day on the project.

The purpose of the actual building project, as outlined by Mr. Roselle, was to give the boys practical experience in the construction of a home.
