Local Man Commits Suicide Sunday at Arlington Heights

Edward De Laurier, 47, Takes
Life by Inhaling Fumes
From Car Motor

Edward De Laurier, 47 years old, 642 N. Hough street, committed suicide near the main entrance of the Arlington Park race track at a little past 10 o'clock Sunday morning by inhaling fumes from a piece of hose to the exhaust pipe of his car, running it up through the floor boards of the machine and sitting there with the motor running until the deadly fumes had taken his life.

The car had been parked beside the road for several hours on Sunday, but it was not until 2:45 in the afternoon that a call was made to the Arlington Heights police. Chief of Police Skog investigated, found the man dead and notified an Arlington Heights undertaker who came to remove the body.

When his body was being taken from the machine, it was discovered how he had met his death. An inquest was conducted at Arlington Heights Monday morning when the jury brought in a verdict of suicide while temporarily insane.

Mr. De Laurier was married and the father of two children. He was formerly employed as an oil burner repairman. Financial reports were reported to have been unimpaired in his section.

He had removed the license plates of his car, but identification was made through some papers in his pocket.

Funeral services were held Wednesday afternoon in Chicago with Rev. C. R. Drussel of Barrington officiating.

Cuba Ranks Second in County for Tax Collection Rates

Ela Township Ranks Fourth;
Treasurer's Books Are
Closed Friday

Cuba township ranked second for the entire 18 townships in Lake county in 1936 tax collections. H. D. Kelsey, supervisor, reported after the release of the annual report of Allen J. Nelson, treasurer, this week. Ela township ranked fourth for the county. The treasurer's books for the 1936 collection year were closed Friday. They showed that there was an increase of 89.0 per cent in the payment of current taxes but a decided drop in the payment of back taxes.

For the valuation year of 1935, for which taxes were collected in 1936, there was a tax extension of \$4,984,736.77 and \$3,502,099.45 in back taxes, or a total of \$8,486,836.22.

While the percentage of current tax collections showed an increase in 20 of 21 municipalities in Lake county compared to the previous year, with an average of 12.45 per cent compared to 81.57 per cent, the payment of back taxes lagged considerably.

This drop, according to the records in the collector's books, was due to a large degree to delinquency during the past year by HOLC clients whose homes are under foreclosure because of default on their loans.

Of all taxes collected during the year, \$4,110,403.94 was for current extensions and \$4,376,432.28 for back taxes.

As for current tax payments in the 18 townships in the county, 15 towns showed increases over the previous year and three of the most notable. The highest current tax payment percentage was shown by Newport township and the lowest by Zion.

Other Lawsuits Face Village in School Hearing

Special Assessment Bond-
holders Asks Funds
Involved in Suit

The village of Barrington must push to a successful completion the suit now pending between school trustees, directors and treasurer and the village in order to avoid additional litigation in the future, trustees were warned Monday night at their regular meeting.

In discussing the case it was learned that A. L. Wiedenbeck, village treasurer, had received a letter from the Assessment Bond Service, Inc., requesting larger payments on special assessment bonds due.

The village is basing the suit on the claim that the former school treasurer paid out money from village funds for school purposes, leaving the special assessment fund with a deficit. This deficit has been reduced by payment of dividends from the receiver of the closed First State Bank of Barrington.

The letter from the bond service company, which serves as collection agent, intimated that judgments might be sought by bondholders on the failure of the village to pay out on the bonds.

If the village fails to reach a settlement of the school affairs and the deficit still remains a suit to recover may be started by bondholders.

A suit is pending in the circuit court of Lake county in which a group of bondholders have united to seek payment. The case has been pending several years and has not been passed, because of village bond payments which were made possible by dividends from the closed First State Bank.

Officials Seek to Improve Crossing

Village President Earl Hatle will appoint a committee of three to wait on the Cook county board of commissioners with the request that the Main street crossing of the Chicago and Northwestern railroad be improved with the county road-widening project. According to information, Milburn Brothers, contractors for widening Main street, are now awaiting orders to proceed with the work. The date has unofficially been set for March 15 with the work to last 82 days, bringing the complete completion to about July 1.

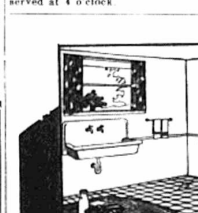

Regional Planning Board Recommends Road Improvements

The Chicago Regional Planning board has recommended a road program to the state highway department to improve roads in the northwest area at a cost of \$2,500,000 during the next two years. Robert Kinsley, general manager of the association and former director of the state public works administration, assisted in drafting the proposal. He pointed out the state highway department has not announced its 1937 program, although the 1936 work is almost completed.

The proposed and recommended program of the Chicago Regional Planning board is that of one group alone and fails to coincide with previous plans made by the state highway department in this area. Dundee road widened, Higgins road widened to a super-highway, route 59 completed, and several others are on the state list but have been overlooked by the regional board in its recommendations.

Some of the recommendations follow:

Route 60, new pavement from Lake Zurich to Waukegan, to cost \$212,000.

Route 59-R, new pavement from Sheridan to Waukegan road, \$64,000.

Route 42, widening to 30 feet from the Old Elm road to Westleigh road, \$50,000.

Route 72, paving six miles from Stark in Kane county to the DeKalb county line, \$240,000.

U. S. 45, Milwaukee avenue bypass from Halfday to Buckley road, \$300,000.

Recommended secondary road construction, together with estimated costs, includes:

Bridge over Fox river at Grass Lake, \$80,000.

Route 176, six miles of bituminous gravel pavement at McHenry with spur to McHenry dam, \$60,000.

Johnsburg road, McHenry county, 5 miles of bituminous gravel paving from Johnsburg to route 173, \$80,000.

Personal Property Delinquents Given to April 1 to Pay

By paying their taxes at the county treasurer's office before April 1, personal property tax delinquents in Lake county can avoid justice court proceedings. It was decided last week at a meeting of justices of the peace, the delinquent tax committee and Assistant State's Attorney Okei S. Fugus.

Court proceedings will be started after April 1 by the county against personal property tax delinquents who have wilfully refused to pay their tax bills or have neglected to make the payments as required by law.

While no pressure will be made on delinquents who are on the poor relief rolls or are working on WPA projects, the county government intends to carry through with the court proceedings to force the collection of taxes from those able to pay.

At the meeting all but one of the justices agreed to take a hand in helping the county collect the delinquent taxes.

The procedure for the collection of the delinquent taxes, as outlined by the committee of the board of supervisors composed of Emmett Moroney, Charles J. Horschberger and Otto J. Boehm, and Assistant State's Attorney Fugus, is to give the delinquents notice by legal publication that the taxes must be paid by April 1.

After that day, the names of

the property owners and the amounts of their tax delinquency will be filed with the justices of the peace in the various communities of the county.

The tax delinquents will then be given the opportunity to make their payments to the justices of the peace. If no payments are forthcoming, regular court proceedings will follow and summonses will be issued against the delinquents to appear for hearings.

Wherever judgments are taken by the county against the tax delinquents, the county may seize personal property and auction it off at a public sale to satisfy the amount of the judgment. Aside from the amount of the tax delinquency, the judgment will include court costs and the expenses of the public sale.

Modern Woodmen Is Reported Solvent

The modern Woodmen of America fraternal insurance society, was declared "one hundred percent solvent" in a report of an examination by insurance department heads of eight states and filed with the Illinois insurance department Monday.

The report, made public by Ernest Palmer, Illinois insurance director who organized the examination following efforts to have the society placed in receivership, listed it as having \$700,000,000 worth of insurance in force and a membership of 500,000.

Floyd died in the Garfield Park community hospital Tuesday of pneumonia. He had been in ill health for the last year and a half, undergoing several operations. He had entered the hospital on February 24 and was believed to have been making satisfactory progress, when death occurred.

The young man was born in Barrington on September 13, 1915, the son of Mr. and Mrs. Alfred Hoben. Since the age of six years, he had made his home with his grandfather, Henry Hoben. He attended Barrington public school and was graduated from high school with the class of 1934. He entered North Central college at Naperville and was in his second year when his illness forced his retirement.
