The December Treasurer's Report was reviewed. The beginning balance was \$12,411,833.49. Revenue received totaled \$1,800,058.60, while expenditures amounted to \$713,054.50 resulting in an ending balance of \$13,498,837.59.

Finance Manager, Lauren Rosenthal, noted that two late tax disbursements were received from Cook County in December.

Deputy Director Katsion highlighted a few items from Director Pinshower's monthly report. He noted that the library's old van was sold to McHenry Public Library District, which will allow them to begin some new initiatives and outreach.

Programs of note in December included the following:

- Capstone Café – 845 students
- Paw Patrol Story Time – 73 participants.
- Winter Reading Program – 34% increase in registrations over last year.
